#### 4601: Apologies for absence: Cllr. Bailey

## 4602: The River Char Project - Ian Rees, Dorset Area of Outstanding Natural Beauty and Nick Gray, Dorset Wildlife Trust explained the first stages of the joint River Char Project, which was initiated by CVPC.

A year ago, CVPC was concerned about the condition of the River Char and obtained a grant to look into this. Nick Gray and Ian Rees are now co-managing the project. They propose to interview local landowners, farmers, residents and businesses using as a model the River Asker project which they have also been managing. The Environment Agency monitors the condition of the River Char and it is rated 'Moderate' which means that it fails to meet certain key water quality criteria. They will look at the biology, physio-chemical pollutants and chemicals within the river. Fish levels are already known to be lower than they should be. Other facts that will be considered are the geology and soil – wet deep clay – and the local landscape – 60% of the area is 'improved grassland'. They numbers of aquatic invertebrates, the work condition and state of the river will also be examined. The level of oxygen in the water has varied between 4.5 and 6 over the last 20 years. Hansford is working with Highways England regarding the road crossing issues at Morcombelake involving cyclists and horse riders.
